

VIDEO SURVEILLANCE POLICY

This policy, according to the GDPR (European General Data Protection Regulation 679/2016, hereinafter "Regulation") regarding the personal data protection, offers detailed information on protection of Your data as well as processed by Melucci S.r.l. (hereinafter "Melucci"), as Data Controller during the accesses and the permanence in the premises, as well as near, Melucci's buildings, or in other services distribution points (hereinafter "Premises"). The recollection, registration, storage, and, in general, the use of images, necessary in terms of access to Premises, sets up personal data processing. In this respect, to complete the information provided to the data subject via the so-called minimum policy "signs" exposed in the appropriate areas of Premises, we communicate You the following.

WHO WE ARE

WHY AND ON WHICH LEGAL BASIS DO WE PROCESS YOUR PERSONAL DATA?

We process Your personal data in order to comply a legitimate interest of Melucci, for the purpose of security, protection and the protection of clients, staff and all the subject that have the access to Your premise, as well as to protect the same Premises and the corporate assets against possible aggression, theft, robberies or acts of vandalism.

WHICH PERSONAL DATA DO WE PROCESS AND HOW LONG?

The processing operations take place with logic strictly related to purpose indicated and, anyway, in order to guarantee the security and the confidentiality of the same data. For this reason, we make it known that:

- Video recording take place by using video cameras which are placed in order to limit the recording of area indeed subjected to risk of illicit or harmful behaviors by subjects unrelated to the business organization;
- The detected images are registered and stored on electronic or magnetic devices, for the period of time strictly necessary to the achievement of purposes indicated. <u>Please note that, the predefined registration time is purposely omitted for security reasons, anyway in order to respect the current regulation, the predefined registration time by the system is made available to the competent Lead Supervisory Authorities in a separate file. However, a longer retention period may depend on the need to comply with specific requests from the Judicial Authority or the judicial police in relation to any ongoing investigative activities.</u>

The detection and the registration of images are carried out without environmental interception of communication and conversation and there is not an automated decision-making process, including the profiling according to the Article 22 (1,4) of the Regulation.

WITH WHO DO WE SHARE YOUR PERSONAL DATA?

Personal data are processed exclusively by the staff of Melucci – Authorized to the processing – or by external companies designated by Melucci as Data Processors. Additional information is available at the sole point of contact for feedback to the Data Subject of the company. In addition, personal data are available at the request of the Judicial Authority and/or qualified entities. Recollected data is not an object of communication, neither is sharing.

TRANSFER OF PERSONAL DATA OUT OF THE EUROPEAN ECONOMIC AREA

Data of registrations are stored into the Melucci's server and reside inside the European Union. Additional information is available at Data Controller.

WHICH ARE YOUR RIGHTS AND HOW TO EXERCISE THEM?

You have the right, with your personal data, to ask for the rectification, deletion, limitation and the opposition to their use for legitimate purposes and the revocation and eventual granted consents (from the article 15 and the following of the Regulation). The appropriate request to the Data Controller is presented by contacting the email created for the data subject feedback or by filling the form available into the dedicated privacy area.

The data subject that believes that the processing of personal data is taking place in breaching of the provisions of the Regulation, shall have the right to lodge a complaint to the Italian Data Protection Authority (www.gdpr.it), as required by the article 77 of the Regulation, or bring the issue before the competent courts (article 79 of the Regulation).
